**THE TRANSMISSION REMANUFACTURING CO. LLC.
 LIMITED NATIONWIDE WARRANTY CERTIFICATE**

THE TRANSMISSION REMANUFACTURING CO. LLC. ("TRC") warrants, to only the original customer shown on the work order referenced hereon, the work described on work order # _____ (and not including any other materials, labor, components, or parts of the vehicle) against failure by defects in workmanship & material for _____ months or _____ miles, whichever occurs first; however, warranty work and/or goodwill repairs do not create a new warranty or extend the original warranty period. If, within the time and mileage specified and the terms of this warranty, repairs on covered parts or labor purchased is necessary, it will be provided within the limits of this warranty at no charge to the customer at any of the "TRC" locations named above; however, "TRC" RESERVES THE UNQUALIFIED RIGHT TO REFUND THE ORIGINAL PURCHASE PRICE PAID IN LIEU OF ALL CLAIMS MADE UNDER THIS WARRANTY. This warranty is NOT transferable.

OBTAINING SERVICE: IT IS ALWAYS THE EXPRESS RESPONSIBILITY OF THE CUSTOMER TO CONTACT AND RETURN THE VEHICLE/TRANSMISSION, AT CUSTOMER'S EXPENSE, TO THE ORIGINATING "TRC" LOCATION SHOULD A PROBLEM WITH THE TRANSMISSION/CLUTCH OCCUR. However, if distance prevents return, "TRC" may, at its discretion, direct the customer to a 3rd party location - selected by "TRC" - for diagnosis. After diagnosis, if a problem is found to exist with the work warranted by "TRC" under the terms of this warranty, you MUST again call "TRC" to receive "TRC's" approval/authorization for repair & to receive a RMA#. THIS WARRANTY IS VOID IF ANY UNAUTHORIZED PERSON/ENTITY TAMPERS WITH THE TRANSMISSION/CLUTCH ASSEMBLY OR WORK BEGINS PRIOR TO AUTHORIZATION BY "TRC". If you have any questions concerning your warranty or the work to be performed, then contact the originating "TRC" location.

THIS WARRANTY DOES NOT COVER (1) damage caused by misuse, neglect, or accident including, but not limited to, broken cases, differentials, one-way rollers, broken gears (2) loss of time and/or earnings, loss of use, rental vehicle, inconvenience, commercial loss, towing charges, shipping charges, per diem expenses, personal injuries, or any other incidental or consequential damages. (3) Damage resulting from Improper installation of the transmission by other than a "TRC" location listed above or if factory approved fluid has not been used in the assembly. (4) Unless you have purchased a Tugger Series Transmission, this warranty does not cover transmissions whose engines are modified to produce more output (horsepower or torque) beyond the original design limits of the transmission. These items include, but are not limited to: superchargers; turbo chargers; nitrous oxide, aftermarket fuel injection systems; internal engine modifications or replacement engines that are larger than what came with the vehicle. It also does not cover vehicles which have had drive train modifications that cause a load on the transmission that exceeds the original design limits. These items include, but are not limited to: substantially larger tires or a change in the differential gear ratio (one that is not available as an option with the vehicle). It also does not cover vehicles that exceed the designed gross weight suggested by the manufacturer (i.e. heavy tool chests, boom etc.) or towing an item that is heavier than the towing limits placed by the vehicle manufacturer. It does not cover any towing charges, rental car expense, lodging of any type, any meals, loss of use, or loss of income, inconvenience, or per diem expense.

The work performed can sometimes fail, due to no fault of "TRC". Parts related to, but not part of, the transmission/clutch which are not covered by this warranty may also be found to be defective after repairs are completed due to inability to test prior to making repairs. This warranty is void and invalid if related parts are found to be defective and are not repaired in a timely manner; or if related parts fail after the transmission/clutch work is completed, thus adversely affecting the transmission, torque converter, clutch or seals. "TRC" cannot predict these events and is not responsible if damage is caused to the transmission, torque converter, clutch or seals under these circumstances. Related parts include, but are not limited to: levers, controls, linkage, flywheel, radiator, coolers, rubber mounts, external oil lines, electrical/electronic accessories, etc.. "TRC" is only responsible for the parts and labor purchased by the customer as reflected by the work order referenced above. "TRC's" obligation under this warranty is limited to, at "TRC's" discretion, replacing or repairing defective parts, correcting defectively furnished labor, or refunding purchase price.

This warranty agreement covers parts and labor as itemized on the customer's repair order on a non-prorated basis for the time period and mileage (whichever comes first) as noted herein. Defective transmissions covered by this warranty will be repaired or replaced, at the option of TRC INC. The cost of transmission parts and labor is covered for units installed by a TRC dealer, and will be reimbursed only after any returned parts are inspected and found to be defective by TRC INC, at the actual shop rate (Up to \$35/hr, U.S. funds) and time determined by Mitchell Labor Manual (maximum of 8 hours is covered for replacement and 3 hours for repair). A unit replaced or repaired under warranty will be warranted for the remainder of the original unit warranty period. The buyer shall be responsible for all defects, thereafter, regardless of cause.

To file a Labor Claim, call 1-800-336-5525 and request form 677, it will be faxed, e-mailed, or mailed to you.

Form 677 must be filled out completely and returned to the General Offices in Kent, Washington before claim processing can begin.

Buyer and seller agree the seller's price is based upon this limited warranty. Buyer and seller also agree the buyer's sole and exclusive remedy against the seller on account of breach of contract, warranty or performance shall be for the repair or replacement at TRC's factory in Kent, Washington, of defects in TRC's factory workmanship or material within the period of this warranty. The buyer will be responsible for shipment and subject to the limitations and conditions of this warranty as contained in this limited warranty declaration.

ALL WARRANTIES, IMPLIED OR OTHERWISE, ARE LIMITED TO THE TERMS OF THIS WRITTEN WARRANTY. CONSEQUENTIAL AND INCIDENTAL DAMAGES ARE NOT COVERED BY THIS WARRANTY SOME STATES DO NOT ALLOW LIMITATIONS ON THE LENGTH OF AN IMPLIED WARRANTY, OR THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES; THEREFORE, THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY HAVE OTHER RIGHTS WHICH CAN VARY FROM STATE TO STATE. THIS WARRANTY AND ANY ACTIONS ARISING THEREFORE SHALL BE GOVERNED BY THE STATE OF WASHINGTON.
